GRILL RESERVATION:

Every effort will be made to accommodate same day reservations for grill usage. Security will need to unlock / turn on the propane tank for resident use. Resident must be present at the grill when security unlocks the propane. Resident must call front desk when they are done using the grill for security can come shut off propane.

If the grill is not returned in proper cleaning conditions, if it has any damage, or it shows the use of charcoal, I hereby authorize Plaza Del Prado Condominium Association, Inc. to charge it to my account.
